环境预处理:将样品置于 40℃,85%RH 环境箱内,在测试区域上施加 340N 的负载,保持 16h,结束后,移去负载,放置实验室环境恢复 24h。

环境预处理后:将样品置于工装上,使用拉力机以 500mm/min 的速度施加至 600N,同速卸载。再以 100mm/min 的速度施加 20N 的预载力并测量高度 h_1 ,继续以 100mm/min 的速度施加至 600N,同速卸载,记录卸载时 320N 时的位移量 ESW_1 和 480N 的位移量 FB




